WHY

Whether your company is new or existing, your vehicles need the required permits and authorities to comply with all transportation industry regulations. Permits & Authorities help you get started and let you grow your business quickly.

A CVOR Certificate is Needed!

Carriers that operate certain types of vehicles require a CVOR certificate, including commercial motor vehicles that are plated in Ontario, the US or Mexico.

These vehicles include:

- Trucks with a gross weight or registered gross weight over 4,500 kg
- Buses with a seating capacity of 10 or more passengers
- Tow Trucks - regardless of gross weight or registered gross weight - Effective January 1, 2017

Note: Vehicles plated in other Canadian provinces or territories do not need a CVOR certificate. They require a **Safety Fitness Certificate** from the province or territory in which the vehicle is plated.

Two Main Steps are required to get your Trucking Authority:

- **In Ontario** - CVOR Registration, IFTA, IRP, Single Trip Permit, etc.
- **For US Carriers** - MC Number, US DOT Number, BOC 3 Processing Agents, UCR, Insurance - Liability and Cargo, etc.
